#### LETTER FROM THE FIRE CHIEF



It is an honor to present the 2016 Annual Report of the Bloomingdale Fire Protection District #1 highlighting the activities and accomplishments of our organization. Through the dedicated efforts of all members of our district, the Bloomingdale Fire Protection district remains committed to service, safety and teamwork in delivering the highest level of service to our community. It is my hope that you will recognize the continued commitment that all of our members provide to the citizens we serve.

Currently, there are 45 dedicated professionals who serve the Bloomingdale Fire Protection District. In 2016, the district answered 4,597 calls for service, which was one of the most in our 111 year history.

In June of 2016, the Insurance Services Organization awarded the Bloomingdale Fire Protection District a Public Protection Class Rating of "1." ISO's staff collects information about the quality of public fire protection in more than 47,500 fire protection areas across the United States. In each of those protection areas, ISO analyzes the relevant data and assigns a Public Protection Classification — a grading from 1 to 10. Class 1 generally represents superior property fire protection. Most U.S. insurers of home and business properties use ISO's PPC in calculating premiums. There are currently only 7 other fire departments in Illinois that are an ISO Class 1.

We continue to benefit from the collective efforts of the West Suburban Fire Rescue Alliance through functional cooperation. Our training, standard operating guidelines, and emergency responses have provided improved service delivery to our residents.

In addition, there were many other notable activities this past year including, but not limited to:

- Implementation of a number of improved computerized databases that have garnered improved efficiency, record keeping, transparency, and statistical analysis.
- Our firefighters completed over 10,000 hours of documented training, covering a variety of topics to ensure that they are prepared for any incident.
- Members were trained in a variety of active shooter incidents and equipped with body armor.
   Our hope is that we never have to utilize this equipment and training, however our personnel are trained and prepared.
- The Bloomingdale Firefighters Union-Local 3272 hosted the Associated Firefighters of Illinois Biennial Convention. This was a huge accomplishment for our personnel and we are proud of their efforts in ensuring a safe and productive convention.

These are just a few of the many accomplishments that have occurred over the past year. Contained throughout this report are further examples of the efforts, skills, commitment and dedication of each and every member of our organization.

We remain committed to providing the best service as we continue to strive to meet the expectations, and ever changing demands of the community. We appreciate the opportunity to serve.

In 2016 the Bloomingdale Firefighters IAFF Local 3272 hosted the 41<sup>st</sup> Biennial Associated Firefighters of Illinois Convention at the Hilton Indian Lakes Hotel and Resort. The convention was well attended with almost 600 firefighters participating in the three days of politics, meetings, speakers, and other activities. The Local received many accolades in regards to the success and professionalism of the convention.

The Local elected Lou Lettenmair as their new President and his term runs through 2018, James Ketcham was elected as Vice President and his term runs through 2017, and Tom Manion was reelected as Treasurer/Secretary and his term runs through 2018.

Contract negotiations continued throughout 2016 and the 2014-2018 Collective Bargaining Agreement between the Bloomingdale Fire Protection District No.1 and the Bloomingdale Professional Firefighters Union IAFF Local 3272 was eventually settled. The Local is looking forward to continued success in working cooperatively with the District and the Administration toward our common goals.

# **ISO PRESENTATION**



On June 22, 2016, the **Bloomingdale Fire District** was awarded the highest Public Classification by the Insurance Service Organization (ISO). The **Bloomingdale Fire District** received a <u>Class 1</u> designation and is now placed in the top 1% of fire departments nationwide and is one of 6 departments in Illinois to be recognized as a Class 1.

We consider this to be a testament to the hard work and contributions made by every member of the fire district in their training, operations, and commitment in reducing fire loss through fire suppression, public education and fire prevention.

Fire Departments across the country are rated by the Insurance Services Office, Inc (ISO) with a numerical indication of the department's abilities. ISO provides advisory services to the insurance industry to help them develop pricing strategies for property and casualty insurance in the United States. Property and business owners in communities with an excellent ISO rating benefit from lower insurance rates.

A community's Public Protection Classification is based on three main areas: fire department operations (50 percent), emergency communications (10 percent), and water supply (40 percent). ISO's evaluation program includes 10 classifications, with 1 being the highest and 10 being the lowest.

A few interesting ISO facts:

- Nationwide 178 departments have a Class 1 designation (47,500 Departments Evaluated)
- In Illinois, 5 departments were previously awarded a Class 1 designation (2,299 total departments)
- ISO's evaluation is completed every few years
- Community Risk Reduction ISO reviews community's risk reduction efforts which allows for extra credit points up to 5.5. That takes into account fire prevention code adoption and enforcement, public fire safety education, and fire investigation.

This ISO honor would not be possible without the support and commitment to public safety from our board of trustees, elected officials, the villages and their water departments and DuComm. Additionally, the training, standard operating guidelines, and enhanced response from being part of the West Suburban Fire Rescue Alliance was instrumental. This is a collaborative effort between many agencies to provide outstanding service to our residents, businesses and visitors of the Bloomingdale Fire Protection District.


### **FIRE PREVENTION**

#### Preventing injuries and damages caused by fires is our main priority.

The goal of the fire prevention bureau is to help business and building owners meet all the requirements of the codes adopted by the Bloomingdale Fire Protection District and those adopted by the villages we protect.

Some of the main aspects of these reviews are:

- Site reviews are conducted prior to any permits being issued to ensure adequate water supply, fire hydrant locations, and that emergency vehicles can safety access and maneuver to all parts of a building.
- Plan reviews are conducted on all aspects of new buildings to help ensure the occupants will be safe from fire and will be able to safely exit the building without being injured. These reviews include:
  - Life Safety
  - Fire sprinkler systems
  - Fire alarm systems
  - Special extinguishing systems
  - Mechanical systems
  - Hazardous materials storage and use
- Field inspections are conducted to verify compliance with all reviews and testing of all life safety items to ensure that all codes were followed and that all equipment is installed and operating correctly.



The key to success is to identify fire hazards and educate the community on safe practices.

### **EMERGENCY MEDICAL SERVICE**

As we strive for excellence within the scope of our roles as Emergency Medical Service providers, obtaining over 1,500 contact hours of continuing education last year, we embrace the mission, vision and values of both the Bloomingdale Fire Protection District and Northwest Community Hospital, our regional resource hospital. We have made notable advances in our ability to serve the community with some fairly revolutionary purchases and implementation of practices. In 2016 we completed 3286 EMS runs resulting in the following types of calls:

With the availability of 3 Medic units and 2 ALS response fire apparatus we were able to handle these calls and request very little mutual aid from surrounding departments. With almost 60% of our transports going to Glen Oaks Hospital in Glendale Heights, our paramedics were able to respond to second and third ambulance requests from the hospital. In 85% of our responses, units were on scene in less than 5 minutes and spent less than 20 minutes on the scene for 80% of our responses.

#### **EMS: An Ever Evolving Practice**

While the statement "EMS is an ever evolving practice" has always been true, this coming year will alter the face of EMS more than ever. In 2016, the Northwest Community Emergency Medical Services System added a new Standard Operating Procedure (SOP) pertaining to Active Shooter Incidents.

Members of the Bloomingdale Fire Protection District have trained with local law enforcement agencies in preparation for unfortunate events surrounding active shooter situations. EMS personnel will now have the capability to coordinate with police personnel to form a Rescue Task Force to enter active areas and extract patients for treatment and transport.

A few members from each of the six fire departments that comprise the West Suburban Fire and Rescue Alliance attended a Rescue Task Force class put on by the Illinois Tactical Officers Association (ITOA). Members trained in conjunction with police agencies and will now be able to teach the skills they've learned to other members of the WSFRA.

This is very new to our District and EMS system. It will require a large amount of training and coordination between EMS, fire and police departments. Our hope is that the end result will be getting injured patients removed from an area of danger, faster treatment and transport to the hospital. The Bloomingdale Fire Protection District No.1 Training Division's Mission is for our firefighters to become: SAFER, FASTER, BETTER AND SMARTER. Our Training Division prides itself on making all of our training realistic, relevant, and referenced.

The training division is responsible for training all career and paid-on-call members in fire suppression, emergency medical service, special operations rescue, hazardous materials, fire investigations, fire inspections services, officer development and other related topics. We are committed to the safety and welfare of our members. Our goal is to have the best trained firefighters and paramedics so that we can deliver the highest quality service to our residents, visitors and neighbors.



We hosted several outside classes in 2016 and continue to strengthen our bond with the community and departments throughout Illinois.

#### New Training Tracking and Delivery Platform WSFRA

The West Suburban Fire Rescue Alliance, WSFRA, made a joint purchase last year for a new training delivery and tracking system. This computer based program is called Target Solutions, a very user friendly way to deliver the training materials. Much like Dropbox or other file sharing programs, Target Solutions has allowed us to compile a large library of training resources. It also has a variety of available courses to use for the compliance requirements as defined by OSHA, IDOL, and NFPA.





#### Training Accomplishments 2016

- Approximately 11,000 hours of training received by our firefighters in 2016, averaging 223 hours per firefighter.
- Each month's training schedule includes: Officer Development, Firefighter Training (individual and company), EMS (Paramedic and EMT), Special Operations Rescue, Hazardous Materials and other required training topics.
- Our members train with the West Suburban Fire Rescue Alliance monthly and completed over 108 separate drills with our six alliance training partners.
- Members participated in over 394 hours (up by 150 hours from last year) of specialized MABAS Team training in 2016.
- Company operations and skills focus for 2016 were: company effectiveness and survival on the fire ground, engine company operations, tower ladder operations, medic company operations, special operations and officer/ leadership development for every level of our organization.
- Individual skills focus for 2016 were: Self-Contained Breathing Apparatus (SCBA) survival skills, fire ground emergency communications, fire hose line tactics, forcible entry skills, ladder placement skills, ropes, knots and rescue system proficiency, fire victim removal and resuscitation
- Emergency Medical System training in 2016 focused on: trauma, medical, cardiac, pediatric, geriatric and several sub-specialties of emergent medical care.

Before our firefighters begin a career in the fire service many start as paid-on-call members. The Paid-on-Call Program remains an integral part of the Bloomingdale Fire Protection District. In 2016, some firefighters in the program were indoctrinated to the world of public service while others used the time to advance their skills. Members Michael Butler, Kyle Murray and Erik Ottosen spent several months in class while earning their paramedic licenses. That license represents hundreds of hours of education, training and experience. Firefighter Tony DiCostanzo completed the classroom portion of his paramedic training and will be entering his practical internship soon. New members Nick Berghaus, Mike Fullerton, and Mitch Ryan attended the fire academy and have brought their skills to benefit the community. Senior member Paul Hoske has used his years of experience to help mentor our youngest members. Each of the paid-on-call members responds to calls, participates in drills, and performs chores as a member of the shift. The district relies heavily on the paid-oncall members to deliver emergency services, to supplement manpower at major incidents, and to provide support for public events.

In 2016, paid-on-call firefighters Mike Zarth and Jonathon Raz accomplished goals and became career firefighter/paramedics in the area. They have worked hard to reach the next level and we are very proud of their achievement. We are confident that both young men will uphold the excellent service Bloomingdale has been known to provide.

Training for part-time employees takes place on the fourth Wednesday of every month. Training this year focused on teaching employees how to drive and operate a fire engine, confidence in wearing a SCBA, tower ladder operations, ventilation, forcible entry, hose deployment, vehicle extrication, equipment familiarization, EMS, rope and knots, and victim removal.

### WELLNESS







Bloomingdale Wellness & Fitness program is dedicated to helping our department become stronger, more flexible, and have an overall healthier lifestyle. We are increasing our department's knowledge in achieving a healthier living style not through just eating healthy but being healthy.

During the year the wellness team was active in researching different equipment. One of the goals for wellness during the year was to equip both stations equally. In doing so we were able to purchase through the FFIB the necessary equipment for Station 23 to mirror the equipment at Station 21. We want to continue to provide the necessary equipment and knowledge to the employees so they have the opportunity to be able to live a healthier lifestyle.

Some of the equipment we were able to purchase was rubber bumper plates, a couple cross-fit bars that are used with the rubber weights and a lifting belt. One of the main purchases this past year for the department was two Gauntlet Stair machines.

Our members competed in 5K races and BC Kurka competed in the Big Sur Marathon. It takes hours of dedication to train for a 5K race and training for a marathon is something only a few can achieve!

# SPECIALTY TEAMS



Self-Contained Breathing Apparatus (SCBA), also known as an air pack, is the back bone of firefighting. Without the air pack, the firefighter would not be able to perform his/her duties such as putting out a house or car fire, performing certain rescues, or enter hazardous situations. Air packs must be worn by each member to provide breathable air in an "Immediately Dangerous to Life or Health" (IDLH) atmospheres.

The SCBA team has been active in maintaining all respiratory protection equipment per National Fire Protection Agency (NFPA) standards #1981 & 1982. We are waiting for the delivery of our new air

packs, the MSA G1 to replace our present aging SCBA air packs. The G1 meets and exceeds the NFPA standards. To help pay for the air packs, Bloomingdale Fire Department received a federal grant in late 2016. With this grant, we will also be able to train two additional firefighters as certified MSA service technicians and increase the number trained to five. SCBA air packs and all masks that are worn range from SCBA (Firefighting), CBRN (Gas Mask), Auga mask (Dive Team), and MSA ½ mask (Investigators).

SCBA program consists of in-depth daily inspection of personal SCBA masks and air packs on each vehicle for readiness. Also every member must also go through annual F.I.T testing which consists of eight separate tests on each mask worn ensuring proper fit and testing for any mechanical problems. Our technicians also perform F.I.T testing for the Bloomingdale police officers and public works employees for the Village of Bloomingdale.

The Bloomingdale Fire Protection District #1 maintains response capabilities, equipment and training for minor hazardous materials incidents within the district response area.

The BFPD #1 is also a member of the MABAS Division 12 Hazardous Materials team which responds to large scale incidents on a local, state, or regional level as needed. Team members must achieve and maintain a technician level certification as well as drill

attendance and training standards in accordance with guidelines established by the fire chiefs,

coordinators, training committees, local, state and

federal agencies as well as the NFPA.

District personnel respond to many hazardous materials incidents throughout the year including carbon monoxide incidents, fuel spills, natural gas leaks and various other minor incidents. The members of the hazardous materials team also will respond to MABAS

Division 12 call outs for personnel on larger spills or leaks.

The Fire Investigation Team is responsible for finding the origin & cause for all fires that occur within the Bloomingdale Fire Protection District # 1. The team includes the Fire Investigation coordinator and three additional investigators.

The process of investigation consists of taking pictures, interviewing witnesses, digging through debris, examining physical evidence, and documentation.

In 2016, the Fire Investigation Team investigated a total of ten fires --nine structure fires and one vehicle fire.

One of our investigators is a member of the Dupage County Fire Investigation Task Force. The investigator is on call for two weeks every other month. The experience that is gained is beneficial for the fire district. We were involved in four investigations with the task force.

Fire Investigation Each of the investigators are required to have continuing education of twenty-five hours a year, over a four year period, to maintain their certification with the State of Illinois Fire Marshall's office. This includes but is not limited to didactic classroom and hands-on training.

The Bloomingdale Fire Protection District (BFPD) #1 Dive and Water Rescue Team operates as a part of the Mutual Aid Box Alarm System (MABAS) Division 12 Dive and Water Rescue Team. The team encompasses all disciplines of water rescue including diving, ice diving, open water, and swift water. The BFPD #1 team responded to multiple emergency response incidents during the past year within our own district and as a member of MABAS Division 12.

The BFPD #1 Dive and Water Rescue Team has two highly trained water rescue technicians who are certified by Dive Rescue International or by Emergency Response Diving International. In addition, members have received several certifications from the Office of the State of Illinois Fire Marshall. Each member of the team is required to complete numerous hours of annual training and meet physical fitness standards to maintain an active status on the MABAS Division 12 team. During 2016 we hosted two MABAS Division 12 dive drills. In addition to continuing to focus on training and safety in 2017, we will also be adding 2 new members to the Water Rescue Team.

As a member of the MABAS 12 Dive and Water Rescue Team, we are part of a highly respected and important emergency services resource organization. In 2016 the BFPD #1 Dive and Water Rescue Team took

part in a Water Rescue deployment drill as a member of MABAS Division 12. The objective of the exercise drill was to show that the team had met the standards necessary for deployment on a nationwide basis. We were successful and our team, as a member of MABAS 12, was approved as deployable. Very few MABAS Divisions in the entire State of Illinois have successfully met the standard for nationwide deployment.

The purpose of the Bloomingdale Fire Protection District's Technical Rescue Team (TRT) is to provide an organized and efficient response to all technical rescues, including but not limited to: vehicle/ machinery extrications, trench, collapse, confined space and vertical rescues/ recoveries, within the community and when providing mutual aid. Although all members of the department are trained in the disciplines of technical rescue, a few have taken extra time to become specialists in what is considered the four major disciplines of the TRT (Vertical Rescue, Confined Space Rescue, Structural Collapse Rescue, and Trench Rescue). These few have also taken on the responsibility of being on the M.A.B.A.S. Division XII TRT.

Division XII is comprised of the following 21 departments: Addison Fire Protection

District, Bensenville Fire Protection District #2, Bloomingdale Fire Protection District, Carol Stream Fire Protection District, Elmhurst Fire Department, Fermilab Fire Department, Glen Ellyn Volunteer Fire Company, Glenside Fire Protection District, Hanover Park Fire Department, Itasca Fire Protection District, Lombard Fire Department, Oak Brook Fire Department, Oakbrook Terrace Fire Protection District, Roselle Fire Department, Villa Park Fire Department, Warrenville Fire Protection District, West Chicago Fire Protection District, Wheaton Fire Department, Winfield Fire Protection District, Wood Dale Fire Protection District, York Center Fire Protection. Out of those 21 jurisdictions 15 have chosen to take an active role in technical rescue making a 67 person team.

In 2017, the TRT team is looking forward to expanding our membership, as we did this year, adding 3 members. We have a large number of qualified individuals, all of whom would be welcome additions to the team. Additionally, next year's training is going to look a little different: the model is going to incorporate much more of the "first-in" operations, heavily relying on the on duty companies (following the WSFRA fire training model) so that our training is more reflective of the way an actual incident will develop.

### **NEW SCBA**



The Bloomingdale Fire District was awarded a grant for the purchase of 44 MSA Self-Contained Breathing Apparatus with CBRN canister use and rapid intervention packs. Also purchased was a new face piece fit testing machine.

# **HOSE AND SMALL TOOLS**



The fire district utilized Waterway Illinois Inc.to test all of our fire hose to the updated NFPA 1962 standard. This is the third year we have used them with positive results. The company was able to test 19,995 feet of attack and supply line in 2 days without any disruption of service to the residents and visitors of the district along with performing NFPA



We will be starting the process to upgrade some of the attack and supply lines for the 2017-2018 budget year. The fire hoses that are currently at the 20 + year life cycle will be evaluated and potentially replaced.

This year, the budget was established to help maintain the current supply of equipment currently Tools placed on our vehicles. There was not an immediate necessity to upgrade anything currently carried



by the suppression companies and with the in-house care and maintenance of the tools, we have not had any large expenditures.

The future goals will be to outfit the engine with a set of battery operated extrication equipment, make upgrades to current thermal imaging capabilities and continue with the care and maintenance.


