Previous Minutes:

A motion was made and seconded (Prokop/Ketcham) to approve previous minutes as submitted. There was no further discussion. The motion passed unanimously. Treasurer's Report:

• Treasurer Prokop reported that there was \$124,125.48 in the FFIB checking account as of 12/01/2022. A motion was made and seconded (Ketcham/Gross) to accept the treasurer's report as submitted. The motion passed unanimously.

 immediately. Rob Spejcher will remain a trustee on the FFIB.
- Annual Election of Board Positions.
 - o Trustee Spejcher will retain his position as chairman.
 - o Trustee Lopez elected to the position of vice-chairman.
 - o Trustee Korinek elected to the position of secretary.
 - o Trustee Prokop will retain his position as treasurer.

Genesis (E-Force)

Trustee Ketcham submitted a proposal on his own behalf for the purchase of a Genesis 41' e-draulic ram, a TL-9 stabilizer lifting plate for the current Genesis spreader on Tower 23 and two Milwaukee M28 batteries. Trustee Prokop asked for an amendment to the proposal to include an additional stabilizer lifting plate for Engine 21 and two more Milwaukee M28 batteries. Trustee Ketcham amended his proposal accordingly. A motion made (Prokop/Gross) to approve \$13,000 for the purchase one ram, two plates and four batteries. Motion passed unanimously.

Hose Rack

 Trustee Gross submitted a proposal on his own behalf for the purchase of a mobile hose rack for Station 23. Motion made to table this proposal until the next meeting.

• Gear Lockers (Station 23)

Trustee Gross submitted a proposal on his own behalf for the purchase of twenty new 'Gear Grid' gear lockers for Station 23. Discussion had regarding removal of the old lockers and install timeframe. A motion was made (Ketcham/Prokop) to approve \$18,500 for the purchase of 20 gear lockers from 'Gear Grid'. Motion passed unanimously.

• Gear Bags and Gloves

Trustee Prokop made a motion on his own behalf for the purchase of 45x Lightening X LXGB10-NL firefighter gear bags and 45x DexPro firefighting gloves. The purpose of the bags is to store everyone's second set of gear in the basement of Station 21 for whenever needed. The gloves are to provide each member with a new set of firefighting gloves. Trustee Lopez recommended not personalizing the bags as this prohibits the ability to reuse the bags once a member leaves. In addition, Trustee Lopez recommended keeping the gloves in storage and only replacing them as needed. Members may request the gloves through the quartermaster. Trustee Prokop amended his proposal to reflect said

changes. A motion was made (Ketcham/Gross) to approve \$9,000 for the purchase of 45x gloves and 45x bags through MES. Motion passed unanimously. Prokop will look into having the bags embroidered with the district logo.
