Motion passed unanimously. Beginning pending balance was \$24,355.00, new pending balance of \$25,555.00.

Trustee Prokop discussed that the Peloton Company has been bought out by another company and several attempts were made my Treasurer Prokop and Chair Spejcher to contact the companies for renewal of subscription. Discussion ensued and unanimously decided to not renew the Peloton subscription for both stations. The district owns the Peloton bikes and are still functional without the online subscription. No bills have been paid for the subscription.

Lawn Mower
