Minutes of the Regular BOARD OF TRUSTEES MEETING February 15, 2018

CHIEF'S REPORT:

Monthly Report:

Chief Janus reported that the district responded to 493 calls in January, averaging 16 calls per shift. The Chief remarked on significant calls for the month including numerous sprinkler breaks. Fire Marshal Kostal provides a daily report to the crews on the status of those sprinkler systems.

Chief remarked on special events during the month: Chief Janus presented at the Lions Club meeting, Chief Janus presented at the State of the Village, Trustees and Chief Janus attended the NIAFD Conference, and the district received a grant from Firehouse Subs for a Utility Terrain Vehicle (UTV).

Chief Janus provided a brief overview of the training that was completed: crews working with new officer development task book. Crews logged over 817 hours of training in January and 1200 drills for the month.

POC Program: Three POC's are attending the COD Academy and the five other POCs are currently securing spots with other academies.

EMS: Crews trained on CPR feedback device and king vision intubation training is upcoming.

Fire Prevention: FPB completed over 100 inspections. FM Kostal continues to monitor Indian Lakes weekly and provides weekly updates regarding sprinkler systems.

Building/Grounds: Public Works unclogged and cleared floor drains, hood system cleaned at Stat 21, and a new MABAS knox box was installed at Stat 21.

We have opportunity to be part of a group purchase, the equipment is compatible with current tools on T23 as well as with tools on alliance departments, and has increased lifting/pulling capabilities as well as increased cutting force.
