## Monthly Report:

Chief Janus reported that the district responded to 372 calls in April, averaging 12 calls per shift. The Chief remarked on significant calls for the month. The district is currently at 1,349 calls for the year, this is 60 calls ahead of last year.

Chief remarked on special events during the month: the chief attended the DuComm groundbreaking ceremony, we attended Senator Tom Cullerton's Senior Fair in Glendale Heights, we attended the ribbon cutting for Lakeview Memory Care, we hosted with the Bloomingdale Park District "I Want to be a Firefighter", and the chief met with labor management.

Chief Janus provided a brief overview of the training that was completed: Bloomingdale hosted high-rise training at Indian Lakes. Crews logged over 792 hours of training in April.

Chief Janus provided a brief overview of fire prevention: Fire Marshal Kostal has attended multiple meetings on July 3<sup>rd</sup> fireworks, the bureau conducted inspections on over 100 new buildings/remodels, 50 annual life/safety, and began inspecting the multifamily complexes.

The Chief shared that Step 4 in the BC and LT promotion process has been completed and posted.
