# Minutes of the Regular BOARD OF TRUSTEES MEETING October 18, 2018

At 4:01 P.M. Trustee Deutschle called the meeting to order.

## **CHIEF'S REPORT:**

## Monthly Report:

Chief Janus reported that the district responded to 384 incidents in September, averaging 12.8 calls per shift. Some notable incidents include: small structure fire in district, crews responded mutual aid to multiple fires, and haz mat incident on Turnberry Court

Chief remarked on special events during the month: hosted lunch on September 4<sup>th</sup> for Lt Myers, attended EMS meeting for new coordinator at GlenOaks Hospital, attended Septemberfest, facilitated electric work for station alerting project, and COD FF Testing initial results received.

EMS: Lt Paliga promoted to EMS Coordinator, attended first ever Chief/Cooordinator meeting at NWCH. Licenses/renewals all up-to-date.

Fire Prevention: Fire prevention very active with new construction/remodels and completed over 105 life safety inspections.

Chief Janus provided a brief overview of the training that was completed: 750 hours completed and 1,141 drills entered. Crew participated in WSFRA Multi-Company Drill with focus of live fire training with single family operations at acquired structure in West Chicago. Four members completing Fire Officer classes and five members attending Company Officer School November 10 & 11<sup>th</sup>.

Vehicle Maintenance: The new engine for M21 is about four – six weeks out and vehicle maintenance members are working very hard to keep vehicles inservice.

Pub Ed: Crews attended Septemberfest parade and provided first aid for festival, crews attended Blue Mass at St Isidore's Church in honor of 9/11, hosted 9/11 ceremony with members of VFW & BFPD, and escorted Bloomingdale Bears Homecoming parades

POC: The POC's attended training on public education in prep for open house.
