**Review of Closed Session Minutes**

Deutschle moved, Gaseor seconded a motion to approve Ordinance 2020-333 – Ordinance Providing for Budget and Appropriation of the Bloomingdale Fire Protection District No 1, DuPage County, Illinois for the Fiscal Year Beginning May 1, 2020 and Ending April 30, 2021.

The Board discussed insurance options for retired members at age 65 and would like insurance broker to reach out to them with additional options.

Gaseor moved, Deutschle seconded a motion to approve the purchase of a new 2020 Ford F-150 SSV as the BC Vehicle not to exceed the price of \$60,000.
